

#### Company Composition:


- In 2023, the company saw a composition of 61% women and 39% men, indicating a marginally decreased proportion of women compared to the previous year's 63%.
- This demonstrates a concerted effort to maintain a balanced gender representation within EVERLEGAL.

#### Top Management Representation:

- Notably, 58% of men and 42% of women occupied top management positions in 2023, showcasing a subtle adjustment from the previous year's figures of 61% men and 39% women.
- This underscores our ongoing dedication to fostering an inclusive environment where talent and merit determine advancement opportunities, irrespective of gender.

As we continue to evolve, EVERLEGAL remains steadfast in its commitment to diversity and inclusivity, recognizing the invaluable contributions of individuals from all backgrounds to our collective success.

# EVERLEGAL CLIENTS WHO HAVE SUFFERED DAMAGES DUE TO THE WAR

Due to the full-scale invasion of the Russian Federation, large, medium and small businesses began to suffer damages.

Our team actively responds to client inquiries and provides legal support on various issues related to the process of documenting and addressing damages for further compensation. Over the past 2 years, we have compiled statistics, according to which 15% of our clients have suffered losses. This is a significant figure that reflects the realities based solely on our work with Ukrainian businesses and international companies in Ukraine.

Understanding the need for quality legal protection of our client's interests, we have developed a legal product to compensate for damages caused by Russian aggression against Ukraine. This product is an important milestone in our commitment to protecting the interests of our clients.

We have already started several complex cases aimed at recovering damages and lost assets. This proactive stance underscores our commitment to protecting our clients' interests and countering unfair practices.

## NEW PRACTICE LAUNCHED

In 2023, EVERLEGAL launched the **Humanitarian Law practice**, dedicated to advising International Organisations, Agencies & Embassies operating in Ukraine during martial law.

### **Briefly about the practice:**

Established to address the urgent needs of International Organisations amidst Ukraine's martial law, offering specialized legal support. We recognised the critical role International Organisations play in providing aid and support to communities in need and sought to empower them with expert legal guidance.

Through this practice, EVERLEGAL reinforces its dedication to making a meaningful difference in crisis-stricken times, one legal step at a time.

## **KEY INITIATIVES**

### > LEGAL HOTLINE

In March 2023, we continue to operate our **Telegram channel and HOTLINE**, offering swift legal assistance to Ukrainian citizens impacted by the ongoing hostilities in Ukraine.

### PRO BONO LEGAL SUPPORT PROGRAM

In 2023, EVERLEGAL maintains its commitment by continuing the **Pro Bono Legal Support Program** initiated in 2022, aiding Ukrainian businesses and NGOs facing legal hurdles stemming from the military aggression by the Russian Federation on Ukrainian soil.

### **"GOOD EVENING. WE ARE FROM UKRAINE" CHARITABLE FUND**

In 2023, we also continued our active work within our charitable foundation "**Good evening. We are from Ukraine**". We unite the legal community and businesses, raising funds to aid the affected population. This ongoing initiative underscores our commitment to crisis support.

### **SEED 2.0**

EVERLEGAL has joined the **SEED 2.0** initiative of the UN General Assembly in Ukraine. It is an educational project of the UN Global Compact in Ukraine. For the third year in a row, the project has been helping to develop small agribusinesses and implement the best business ideas in the agricultural sector.

### **UKRAINE BUSINESS COMPACT**

In June 2023, EVERLEGAL became a signatory of the **Ukraine Business Compact 2023**, which includes principles for longterm sustainable economic recovery in Ukraine initiated by the Ukraine Recovery Conference (#URC2023). These principles were presented at a global conference in London and now unite responsible businesses willing to contribute to Ukraine's recovery.

### **DANISH REFUGEE COUNCIL**

### The mission of this fund:

Humanitarian support of internally displaced people of Ukraine, especially those who came from the most damaged territories of Ukraine and experienced the most tragic events in Ukraine (i.e., Mariupol, Kharkiv, Sumy, Irpin, Bucha, Hostomel, Donbas etc).

### What we have done so far

During this year, to support Ukrainian citizens and defenders, our Charitable Fund:

- implemented more than 9 projects; and
- donated more than UAH 10,000,000 via the partnership with Ukrainian and international companies and organisations.

## EL & LifeLine Ukraine



### C Lifeline Ukraine

EVERLEGAL has been providing Pro Bono legal support to Lifeline Ukraine for 5 years now.

Lifeline Ukraine is a 24-hour, 7-day-a-week national, professional suicide prevention and mental health support hotline. Since 2014, Ukraine has been losing far too many veterans to suicide, and this issue had to be addressed. Initially, Lifeline Ukraine was founded to help veterans and their families, but now the hotline serves all Ukrainians in any language they choose.

Lifeline Ukraine was founded by Paul Niland, an Irish writer, commentator, and businessman who has been living in Ukraine for nearly two decades. The project was launched in 2019 at the request of Dr. Ulana Suprun, the then-Acting Minister of Health. The Ministry of Veterans' Affairs, the Ministry of Social Policy, and the Ministry of Defence all support the project.

### The results of our work for 2023:

In 2023 we devoted more than 50 hours of our lawyers' time to support the organisation and to contribute to **Goal 3. Good Health & Well-Being.** 

Our team assists the organisation with a wide range of issues, from legal advice at the start-up stage to advice on various employment and tax issues, documenting relations with donors and volunteers, etc.



### **#4 PROJECT**

## EL & Danish Refugee Council



COUNCIL

EVERLEGAL acted as a legal partner to the Danish Refugee Council (DRC), an International Organisation in Ukraine, on implementation of the project aimed at helping millions of Ukrainians around the world.

### Briefly about the project:

DRC developed a unique legal online platform (Cross-Border Legal Aid Platform) that is available to Ukrainians wherever they are.

#### The platform includes:

- · legal support of Ukrainians in various jurisdictions;
- convenient formats for obtaining the necessary information in the relevant country;
- quick and open access to information for every Ukrainian;
- modern online consulting systems.

### Our work

During the first year of our cooperation, the platform was already implemented and filled out, and it provides support to Ukrainians.





In June 2023 EVERLEGAL started cooperation with USAID/ENGAGE as an implementation partner in an educational project aimed at providing legal support to civil society organizations, small and medium-sized enterprises, and Ukrainian citizens.

### Briefly about the project:

The main goal of this project was to provide citizens, as well as CSOs and SMEs, with knowledge about martial law and other regulatory changes introduced during the war, as well as to provide participants with practical advice on their life, work and volunteering under martial law and how to properly address new challenges.

- Prepare final report outlining the work done and achieved results with main challenges and achievements.
